1. **All England Direct** (Butterworths Services) - covers same & next day digest summaries of current cases on the All England Reporter; All England Law Reports (dating back to 1936); Official Transcripts (from 1997 to date); All England Commercial Cases (dating back to 1999); & All England European Cases (dating back to 1995).
2. **Encyclopaedia of Forms & Precedents** (Butterworths Services) - a popular online source of precedents in all areas of non-litigious practice, with concise commentary on the law & drafting guidance.
